## **IJUDA - Access Policy**

The International Journal of Underwater Domain Awareness (IJUDA) is introducing a free access model for its inaugural volume, with a paid access model planned for subsequent issues and volumes.

### **1. Access to Volume 1, Issue 1**

Volume 1, Issue 1 of IJUDA is being made available to readers free of charge as part of the journal's launch.

Readers may create a free account on the IJUDA website to access the full text of articles published in Volume 1. No payment or subscription fee is required to access the content of Volume 1, Issue 1.

### **2. Access to Subsequent Issues and Volumes**

From Volume 1, Issue 2 onward, IJUDA will transition to a paid access model. Readers will be required to purchase access or hold an applicable subscription to access the full text of articles in issues and volumes covered by the paid-access model.

The journal website may continue to provide publicly accessible article titles, abstracts, author information, keywords, and other bibliographic details to support the visibility, discovery, and indexing of published research.

### **3. Author Publication Charges**

IJUDA does not charge authors or their affiliated institutions any Article Processing Charges (APCs), submission fees, editorial processing fees, or page charges for the publication of accepted articles.

### **4. Reader Access Charges**

Any charges introduced by IJUDA will apply to reader access to the published content and will not constitute a publication fee for authors.

## **IJUDA - Privacy Policy**
